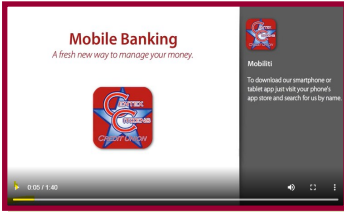
She enjoys spending time with her husband, Sebastian and little boy, Dante.
